About the Program

Applied Econometrics is a discipline of Economics and Mathematics concerned with the use of statistics to describe economic processes. Applied Econometrics evaluates theories, develops econometric models, and analyses history, and forecasts using theoretical econometrics and data. This course will blend analytical and computer-based (data) content to provide participants with hands-on experience with a wide range of econometric issues. The sessions will be interactive along with the application of STATA.

Learning Objectives

At the end of this program participants will be able to:

- Conduct independent econometric and statistical analysis of data in an applied research setting.
- Use econometric software for data management and statistical analysis.
- Demonstrate their understanding of applied econometric analysis models/ methods with respect to the choice of models, estimation method, and interpretation of results.

Pedagogy

The topics will be covered by lecture sessions along with hands-on practical training using databases and computer software STATA. The datasets will be provided to the participants to practice the applications of the techniques learned under different modules to real-world problems.

Academicians, analysts, and doctoral candidates in economics, humanities, management, and other social science fields who plan to do research using econometric models.

Keynote Speakers



Prof. (Dr.) Pami Dua

Dr. Pami Dua is Former Director and Senior Professor of Economics at the Delhi School of Economics. She was a member of the first Monetary Policy Committee of the Reserve Bank of India from 2016 to 2020. She is currently an Honorary Distinguished Fellow (Non-resident) of the Indira Gandhi Institute of Development Research (IGIDR), Mumbai, and a member of the Governing Council of the Centre for Advanced Financial Research and Learning (CAFRAL). She is also a member of the Governing Council of the Madras Institute of Development Studies (MIDS). She is affiliated with the Economic Cycle Research Institute in New York.

She earlier served as the President of the Indian Econometric Society and as Editor of the Indian Economic Review, a reputed journal of the Delhi School of Economics, for almost two decades. She has published widely in reputed international journals as well as books and book chapters in her fields of study viz. time series econometrics, forecasting, macroeconomics, monetary policy and business cycle analysis. She earlier taught at the University of Connecticut, USA and Wayne State University, Michigan, USA and has also been affiliated with Yale University as well as Columbia University.

She obtained her Masters (with distinction) and Doctorate in Economics from London School of Economics.



Prof. (Dr.) Vikas Kumar

Prof. Vikas Kumar is an Associate Dean for Research Innovation and Enterprise at the Faculty of Business, Law and Social Sciences, Birmingham City University, UK. He is also a Professor of Operations and Supply Chain Management. Prof Kumar has over a decade of teaching and research experience. Prof Kumar holds the title of Chartered Management Business Educator (CMBE) and is fellow of HEA. Prior to joining BCU, he was Director of Research and Scholarship at Bristol Business School, University of the West of England. Prof Kumar has also worked in India, Ireland and Hong Kong. He has published more than 250 papers in leading journals and international conferences of high repute. Prof Kumar serves on the editorial board of several international journals, including the Journal of Business Logistics, the International Journal of Physical Distribution and Logistics Management, and the International Journal of Mathematical, Engineering and Management.

He has worked on several international collaborative projects with researchers from UK universities and from Brazil, Vietnam, Thailand, Indonesia, India, Mexico, Taiwan, Jordan, Columbia, Peru, Costa Rica, and Turkey.


Prof. (Dr.) Shyam Menon
